# **Operational Guidelines**

- The Information regarding Outreach and Extension programs to be disseminated through the PRO and also through information in the website, separate notices and to be involved with the Heads of different Schools of the University.
- 2. The University appreciates the services provided by students and faculty byconsidering their working for such activities as on duty and also to network with various student bodies, clubs. NSS activities, different cells, faculty expertise, MOUs and the social initiatives.
- 3. The faculty in charge of the above units will be given appropriate training and also Training is given to thestudents before starting their work in communities. The students will be provided with facilities to participate in community extension activities with appropriate monitoring by the faculty.
- 4. MGU ensures that the students who are engaged in the community outreach activities are required toobserve appropriate standards of behaviour in the campus, community interactions.
- 5. Students are to fulfil requirements such as Indemnity and also to obtain consent from parents/guardians, informing the faculty, HoDs of their respective Schools and maintaining the records of their activities.

The students who are engaged with Outreach and Extension programs are expected to maintain a record of the community extensionactivities in a prescribed format.
